### POINT RACE to the CHAMPIONSHIP

Completed form and fee must be received by Rev. Wind Martial arts before February 20, 2010, in order to receive discounts.

Welcome to the RACE! Every competitor will be representing their school. Each time a competitor places 1st, 2nd or 3rd they will receive points. 5 pts for 1st, 4 pts for 2nd & 3 pts for 3rd. Every point goes toward the competitors school total. The school with the most points wins the Grand Championship!

1st, 2nd & 3rd PLACE TROPHIES WILL BE AWARDED for individuals & Grand Champion winning schools.

Open Score Rules. There will be 3 to 5 Judges. Each Judge will award 5 to 9 points. In the event of a tie, the highest & lowest score will be thrown out, and the balance totaled.

NOTE: If scored on while on the ground, your opponent gets 3 points for the technique.

#### Sparring

##### A. Sparring Equipment

1. Required (Cannot Spar Without) Hand, Foot, Head & Mouth protectors
- Groin protectors (for males)

##### B. Matches

2. Three Point Spread or Most Points within Two Minutes Wins
3. Automatic Disqualification after one Warning (Majority Vote)
4. In case of tie – Sudden Death

##### C. Voting and Decisions

5. Referee and Judges have One (1) Vote Each
6. Majority Vote determines a Point, Warning or Disqualification

##### D. Target Area – Face, Head and Body (No Groin or Spine Contact)

##### E. Legal Techniques – Punching, Kicking & Grabbing

Sweeping of Front Foot (only) is also Legal With One (1) Second allowed to score after Grab or Foot Sweep

##### F. Points

7. One (1) pt for hand contact; Two (2) pts for kick to body; Three (3)pts for kick to head or if taken down and scored on
8. No Point – Uncontrolled or Heavy Contact (Either Warning or Disqualification/Majority Vote)

##### G. Technique/Sparring Area

9. Technique should be judged by Competitors Rank and Ability
10. Sparring Area – Point is Scored if both competitors have at least One Foot in the Ring. Competition does not Stop unless a Competitor is Completely Out of Ring

##### H. Automatic (no warning) Disqualification for

Groin Attack, Sweeping of the Support (Back) Leg, Judo Type Throws, Eye Gouging or any Deliberate Attempt to Injure Opponent

##### I. Disqualifications (After One) Warning

11. Any Injury such as Bruising, Bleeding (not including minor cut) Swelling, etc.
12. Refereeing Own Student or Sideline Coaching
13. Unsportsmanlike Conduct or Taunting (Competitor or Spectator)
